<ul> <li>At least 30 days before the later of:</li> <li>a) The program start date in the most recent Letter of Acceptance (international students)</li> <li>b) The program start date in the enrollment contract.</li> </ul>	Institution may retain up to 10% of tuition, to a maximum of \$1,000. Institutions must refund fees paid for course materials if not provided to the student.	
<ul> <li>More than seven days after the student and institution signed the enrolment contract, and</li> <li>Less than 30 days before the later of: <ul> <li>a) The program start date in the most recent Letter of Acceptance (international students)</li> <li>b) The program start date in the enrollment contract.</li> </ul> </li> </ul>	Institution may retain up to 20% of tuition, to a maximum of \$1,300. Institutions must refund fees paid for course materials if not provided to the student.	
After program start date, institution provides a notice of dismissal or receives students, except those enrolled in a program delivered solely by distance educed and the students of the start date of the start date.		
<ul> <li>After the program start date, and up to and including 10% of instruction hours have been provided.</li> </ul>	Institution may retain up to 30% of tuition. Institutions must refund fees paid for course materials if not provided to the student.	
<ul> <li>After the program start date, and after more than 10%, but before 30% of instruction hours, have been provided.</li> </ul>	Institution may retain up to 50% of tuition. Institutions must refund fees paid for course materials if not provided to the student.

<ul> <li>Students do not attend the first 30% of the program.</li> </ul>	Institution may retain up to 50% of the tuition.

Institution receives a refusal of study permit (applies to international students requiring a study permit):			
<ul> <li>Before 30% of instruction hours would have been provided, had the student started the program on the later of the following:         <ul> <li>a) The program start date in the most recent Letter of Acceptance</li> </ul> </li> </ul>	100% tuition and all related fees, other than application fee.		
b) The program start date in the enrolment contract

After the program start date, student withdraws or is dismissed (applies to students enrolled in a program delivered solely by distance education):			
<ul> <li>Student completed up to 30% of the program.</li> </ul>	Institution may retain up to 30% of the tuition.		
	Institutions must refund fees paid for course materials if not provided to the student.		
<ul> <li>Students completed more than 30% but less than 50% of the program (based on evaluation provided to students).</li> </ul>	Institution may retain up to 50% of the tuition. Institutions must refund fees paid for course materials if not provided to the student.		
Student enrolled in a program without having met the admission requirements for the program			
<ul> <li>If the student did not misrepresent the student's knowledge or skills when applying for admission, the registrar orders the institution to refund tuition and fees.</li> </ul>	100% tuition and all related fees, including application fees		
Institution does not provide a work experience			



٠	The institution fails to provide the work experience within 30 days of	100% tuition and all related fees,
	the contract end date, unless the registrar determines the institution	other than application fees
	was prevented from doing so by circumstances beyond its control.	

Institutions must pay the tuition or fee refund **within 30 days** after receiving notice of withdrawal or refusal of study permit; providing a notice of dismissal, or the date on which the first 30% of the hours of instruction are provided (no-show).
